A message from Dr. deChiara,

At the last PSO meeting, I explained a change to one of the Massachusetts General Laws that relates overall to school discipline. Many of the changes do not pertain to the majority of students at Deer Hill School, but there is one change many of you may notice.

In an effort to reduce truancy throughout the state, school principals are now required to send a letter to parents and guardians of students who have accumulated five or more unexcused absences, explaining that attendance is crucial to learning and unexcused absences are detrimental to students' achievement. Principals have always been required to send such notices home after a large number of absences, but this is the first time "unexcused absences" has been defined to include days when the family is away from school on vacation. The number (5) is a lesser number of absences that must "trigger" than before as well. The letter must be filed in the students' cumulative file. The law does not change for "excused absences" which includes days when children are sick or bereaved.

Please know that I do respect parents' and guardian's prerogative in taking their children out of school for a special occasion, but also that it is the responsibility of all educators to promote consistent attendance and to point out the potential adverse impact on children's learning if there are too many unexcused absences. I have always felt it my responsibility to send this as a clear message, but because of the change to the law, I have no discretion in the matter.

Reminder: Students should arrive at school between 8:20 and 8:30 am. We are not able to provide supervision prior to that time period.

If you've not already done so, please send in a picture of your child for the picture board in Dr. deChiara's office.
